**ESTABLISHED IN 1997**

Each year, the Business Law Section presents a Section member with the Dennis H. Replansky Memorial Award. Dennis Replansky, a former Business Law Section Chair, was a 51-year old senior partner at the law firm of Blank Rome Comisky & McCauley when he died in March 1994. The Section established the Award in recognition of Dennis Replansky's career as a lawyer and his contributions to legal, civic, religious and other charitable causes.

The Award is presented at the Section's Annual Reception. The Award recipient has the privilege of designating a public interest organization to receive the Section's annual charitable contribution.

The Award criteria, reflecting the qualities and actions honored in Dennis Replansky's life, are:

- Superior legal talent in the area of business law.
- Unique contributions to and significant achievements within the business law community in the Philadelphia area.
- A reputation for mentoring young attorneys.
- Significant participation in and contributions to civic and charitable causes in the community.
- Uniform recognition in the legal community of the candidate's honesty, integrity and professionalism.
