



**The Albert S. Dandridge, III
Business Law Section Diversity Award**

SUMMARY OF THE AWARD 2016

Purpose of Award:

The award is named after Albert S. Dandridge III, a former chair of the Business Law Section and Chancellor of the Philadelphia Bar Association who has championed diversity throughout his career and was instrumental in the effort to establish the Section's Diversity Action Plan. The Business Law Section established the award to publicly acknowledge, recognize and honor an individual or entity that (i) has demonstrated a strong commitment, and has made a substantial contribution, to diversity; and (ii) promotes full and equal participation and inclusion in the legal profession. The award is accompanied by a donation made on the recipient's behalf to an entity that embodies the Business Law Section's commitment to diversity and inclusion.

Criteria:

The award shall be granted to an attorney, jurist, law firm, law department, legal services organization or law school in Philadelphia, or an individual or entity that has made a substantial impact upon the Philadelphia legal community. Nominees should demonstrate a sustained and continuous contribution, or a single outstanding contribution, to diversity and full and equal participation and inclusion in the legal profession. The Business Law Section's Diversity Action Plan may be used as a guide. Nominations of individuals should be based upon their personal contributions to diversity, and nominations of entities should be based upon programmatic activity.

Nomination Process:

To make a nomination, please submit the Nomination Form on the next page. Nominations are **due by 12 p.m. on Friday, November 4, 2016** and should be sent to: E.
