# MEMBERSHIP FEES

## First-Year Attorneys

Attorneys admitted to practice before any court of record for less than one year are entitled to a free, one-year membership. Section dues still apply. Attorneys who have previously been admitted to practice in another state do not qualify.

## Members

Those admitted to the Bar one year or more but less than two years, \$99; two years or more but less than four years, \$199; four years or more but less than ten years, \$299; ten years or more, \$399. *Full-time members of law school faculties may join as regular (voting) members.*

## Public Sector Members

For those who are employed full time by a public interest agency or by a federal, state or local government agency, and who have never been a member of the Philadelphia Bar Association, first year's dues, waived; admitted to the Bar one year or more but less than two years, \$50; two years or more but less than four years, \$100; four years or more but less than ten years, \$150; ten years or more, \$200.

## Associate Members *(Not eligible to vote.)*

Maintaining a principal office for the practice of law in Bucks, Chester, Delaware or Montgomery Counties, Pennsylvania; or Camden County, New Jersey, \$175; full-time members of law school faculties, \$175; law firm administrators, \$130; law librarians, \$130; other associate members, \$150; paralegals, \$65; law students, \$20.

## Senior Members

A regular member for at least 25 years who has reached the age of 70 years, or is 65 and retired from active practice. A written request must be made to become a Senior Member, \$60.

---

**Note:** Your date of admission to the Bar shall be calculated from the date you were first admitted to practice before any court of record. Your first year's fee shall be one-half the annual membership fee if you join on or after July 1, but before October 1. If you join after October 1, you pay no fee for the remainder of the calendar year, and your full year fee amount is applied to the following year beginning January 1.

\$2.50 of your membership dues goes to the publication of the *Philadelphia Bar Reporter* newspaper, and \$2.50 of your membership dues goes to the publication of *The Philadelphia Lawyer* magazine.
