SUMMARY OF THE AWARD 2016

Purpose of Award:

The Business Law Section established the award in recognition of Dennis Replansky's career as a lawyer and his contributions to legal, civic, religious and other charitable causes. Replansky was a 51-year-old senior partner at Blank Rome Comisky & McCauley LLP when he died in March 1994. He was a former chair of the Business Law Section. The award recipient will receive the privilege of designating the recipient of the Business Law Section's annual charitable contribution to a public interest organization.

Criteria:

The award shall be granted to a member of the Philadelphia Bar Association's Business Law Section. Nominees should demonstrate superior legal talent in the area of business law; unique contributions to and significant achievements within the business law community in the Philadelphia area; a reputation for mentoring young attorneys; significant participation in and contributions to civic and charitable causes in the community; and uniform recognition in the legal community of the nominee's honesty, integrity and professionalism.
