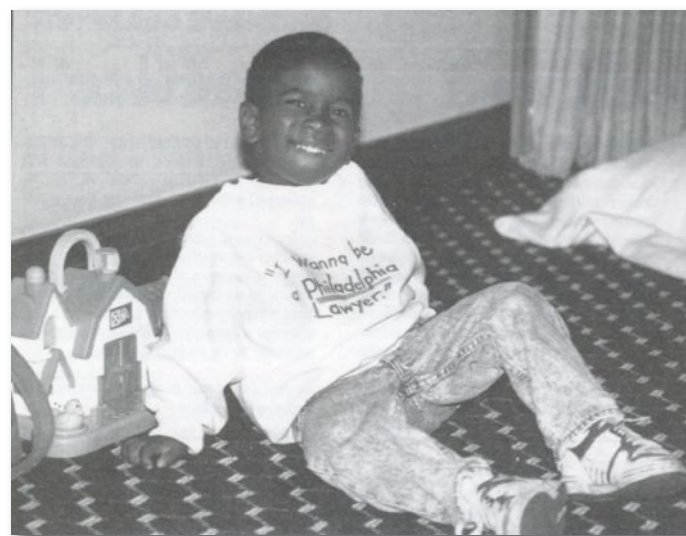

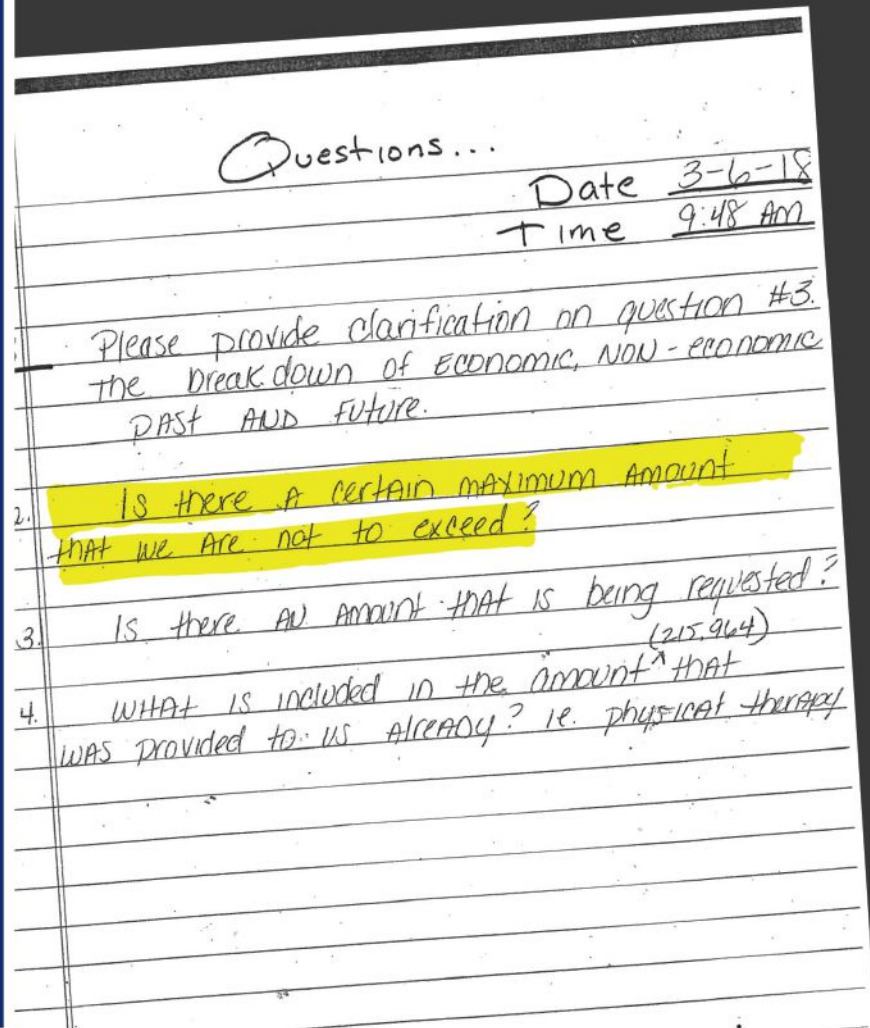
On the evening of Friday, Sept. 14, a gala reception was held at the birthplace of American railroading, the “roundhouse” of the B & O Railroad Museum.
